Mayor's Report

Approval of Minutes from the January 15th, 2013 & January 24th, 2013 Village Board Special Meeting

John Fuller-Village Hall Renovations

The Village Engineer, John Fuller, was present in regards to the Village Hall Renovations. He spoke in regards to the Village Hall renovations being done in phases, so that the Village Budget does not take such a large hit at one time. The phasing concept will also allow the Village to begin to save money in regards to heating which is one of the Village's biggest expenses. Mr. Fuller proposed a phase that would include fixing all of the windows, addressing plumbing issues, repairing the current façade of the building in crucial areas and repairing the roof. As per Mr. Fuller, he spoke briefly with the Treasurer in regards to the

budget and the funds to facilitate this project will have to be bonded for each phase of the project.

<u>Presentation from Chet Schneider from Marshall & Sterling for the Village of Monticello Employee Heath Insurance</u>

Chet Schneider presented Empire Blue Cross & Blue Shield Insurance for Village Employees. The presentation included a PPO Medicare Plan for the Retirees with a savings up to \$65,000.00.

Kathy Kreiter-DeHoyos Park Presentation

Kathy Kreiter & Glenn Pontiere presented the Village with a 1st Prize plaque and Award from Sullivan Renaissance in the amount of \$10,000.00 for the Dillon Park Project.
