Approval of Minutes from the January 7th, 2014 & January 10th, 2014 Village Board Meeting

Discussion: Water bill grace periods

There was a discussion of the Board regarding the grace periods to be given for water bills. It was decided that if the bill due date falls on a weekend day, there will be a seven (7) day grace period and if the bill due date falls on a week day, there will a five (5) day grace period given.

Resolution authorizing a \$35.00 fee for bounced checks as stated in the fee schedule and requesting that all future payments be made through cash, bank check or money order only
