Mayor Jenkins thanked the Board for their support and condolences during the passing of his mother.

Interim Village Manager's Report

USDA

Mr. George Popp arrived to review the paperwork prepared by our Treasure and accountant. He was very pleased in the results. Mr. Popp began to talk about the water grant, I informed him the village is in need of help, the existing water lines in the village are over 100 years old and we do not want to wait too long to start replacing them, explained that if the village had a replacement plan and start the process, even doing sections at a time, this will be a major process, and the village does not have the money. I explained that if we have a major break, it will most likely happen in the winter, resulting in a major cost

increase that the village cannot afford. Mr. Popp understands our problem he stated that right now money is not there, but he will keep us in mind and look for some monies to become available. Mr. Popp will be back for a Nov. 20 update to review the remaining accounting documents. Many thanks to our Treasure Lilu, a great job.

The Senior Center

Ms. Jessie-Ann Rosenbaum out part time employee at the senior center is working out great. But the board has to realize that she is only allowed to work part time 20 hours per week, we still need coverage, the building is open Monday thru Sat. 9am to 10pm, additional people are required.

A suggestion, we have an existing worker that has been working from the Work Force, Shaeshia Foy, Miss Foy came on board about a month and a half ago, she has jumped right in and kept working very hard, she started to organize the paperwork, help out with coverage, I might add some on her own time. I know she has a limited background, but she has worked above and beyond her required work, I would like to suggest the board consider her as a part time employees possibly hired under your part time program, this would allow the board to see her work habits, allow her to learn the job duties, and acquire the needed background that is required for the Recreation Attendant position. The village would benefit, the senior center would benefit, and Miss Foy would benefit. For what it matters, I think this individual wants to work, wants to help, wants to do it right, wants to learn, she would be a great find for the village.

The next suggestion if no one can be hired, is to cut the hours of operation of the senior center, cutting out nights during the week and (day and night) on weekends this would keep it open for 40 hours per week until new employees can be hired.

The Library

The Board still has to decide on the Inspection fee charge, at present it is 4%, the Library has paid the building permit fee and has finished with the asbestos work, they are maintain a list of local work activity they are doing. The Board needs to make a decision on how they want to handle this.

A suggestion might be to ask for an Escrow account to be set up, for and Engineering inspections if needed, Legal activity if needed, and inspections if needed, that our building inspector would do.
