Approval of Minutes from the October 20th, 2015 meeting

A motion was made by Trustee Rue with a second by Trustee Bennett adding an amendment to #25 to state "subject to USDA approval". Upon the call of the roll, all were in favor.

<u>Continuation of the Public Hearing on the Kapelow Structure at 106 Liberty and Crystal Street</u>
Village Special Council, Michael Davidoff stated that this Public Hearing is still being postponed until December 15th, the property owner is making progress in correcting the violations and working on the roof, but we still want to keep this on the agenda as a precautionary measure.

A motion was made by Trustee Rue with a second by Trustee Weyer to postpone this Public Hearing until Tuesday, December 15th, 2015 at 5:30pm. Upon the call of the roll, all were in favor.

Public Hearing-Local Law #5 of 2015, to Repeal Sections 280-40.1 entitled, "Artist Lofts" in B - 2 District and 280-40.3 entitled, "Entrepreneur Lofts" & Local Law#6 of 2015, to Enact Section 280.-40.5 entitled, "Residential Use in the B-2 Zoning District"

Richard S. Baum, Deputy Special Council for the Village made the Public aware that these Local Laws are before the Village Board and have been handed down from the State so that the Village will be in a better position for grants and things of that sort. The Zoning committee met for several months to come up with what they felt would be feasible and friendly for property

owners on Broadway, which is to allow residential use on the second and third floors of their buildings. The apartments will be limited to 1 & 2 bedroom units, for a single individual, couple or small family. Municipal parking lots will be utilized for the residents of these apartments. Any and all other specifications are listed in the proposed local law.

Appointment of Treasurer

Manager Report

The contract with Mobile Medic has been executed, with a start date of 11/15/15. Monthly payments shall be received on or before the 15th of each subsequent month. Please note that the 1st month's payment has been received. I would like to discuss with the Board at a future date consideration for earmarking at least a portion of the monthly rental income for a specific capital fund for the Neighborhood Facility. First on the list of capital improvements would be the purchase and installation of an automated handicap accessible door for the Monticello Seniors.

With regard to the Neighborhood Facility, LED bulbs have been installed above the 3 garage doors. In addition, LED fixtures have been added to the left side of the building, as well as, above the front and rear entrances to the building. All of these lights are on a dusk to dawn setting and really help to light up the building for both safety and aesthetic purposes.

Today, the Water Department had attempted to cap the hydrant in front of Colosseo Restaurant to fulfill our in-kind services agreement with Sullivan Renaissance, however, they encountered problems and it was decided that we would complete that project in the spring. The department will create a barrier around the hydrant with 6" x 6" ties to protect it from being struck by vehicles.

Trustees Weyer, Gomez and I met with representatives from Sullivan Renaissance to discuss the parameters of their recently announced Municipal Grant Opportunity. Following a brainstorming session, we believe we have addressed all of the significant components of the grant and look forward to submitting a highly competitive application. Applications are due by November 30, 2015.

I have reached out to the Municipal Energy and Gas Alliance (MEGA) to receive quotes on potential energy savings by switching to them as our provider of electricity. MEGA is recognized by both NYCOM and NYSAC as a responsible energy cooperative that has partnered with hundreds of statewide municipalities to save them on their energy rates. I know that Sullivan County has utilized MEGA for a number of years and has been pleased with their service and cost savings. Once I have received their quote, I will forward to the board for review and consideration.
