### **Manager's Report**

Mr. Sager reported that he and the Code Enforcement officer, Mr. Brawley, have been assertive with the property clean-ups regarding snow removal on the sidewalks. They are actively working with the Highway Department to violate the offenders and get them cleaned and then send out the bills, so far, it seems to be working well.

## Resolution authorizing the Village Manager to sign an agreement with General Code for Codification Services in the amount of \$13,500.00

# Resolution authorizing the assistance of Barton & Loguidice in the negotiations with Sullivan County regarding the water & sewer connections for the proposed County Jail Annexation. All incurred expenses will be paid by Sullivan County

A motion was made by Trustee Nikolados with a second by Trustee Weyer with a question.

Trustee Weyer asked if there is an anticipated cost, the current proposal starts at around \$10,000.00.

Mr. Sager responded that we are not sure yet, but we are not looking to have a huge bill with them for the County to pay. B& L has inherent knowledge about projects like this and will be an asset on behalf of the Village, just as they were a huge benefit in our current sewer and water projects. We will also have our Village Engineer, Glenn Smith present at these meeting due to his historical knowledge of the Village that will not be known by B & L and then myself and Michael. The bills from Michael and Glenn will be small and will eventually dissipate completely and we are not looking to over extend the County with B & L bills, but their input is vital due to the current projects that we currently have going on.

# Resolution authorizing the Accela Annual Maintenance fee for the KVS accounting software in the Village in the amount of \$6,550.25 to be paid from the General, Water, Sewer & Sanitation Funds in the amount of \$1,637.56 each

Trustee Weyer asked so the whole loan was the 7.8 million?

Mr. Sager responded yes, that's the amount that we received from EFC and that's what we're paying off, plus the interest.
