Mr. Sager reported that the CFA grants were completed and submitted. Stated that he worked all day on the Sullivan Renaissance Municipal Grant with the help of Trustee Weyer and delivered that to the CVI building today in Liberty.

### Resolution giving special permission to the sponsor to invoke Section 82-4 for the Bagel Festival to suspend Chapter 82 during the Bagel Festival to be held on August 13<sup>th</sup>, 2017

A motion was made by Trustee Nikolados with a second by Trustee Weyer to open this up for a discussion of the Board. Upon the call of the roll, all present were in favor.

Trustee Weyer stated that she would like to know what the concerns of the Board are.

Mayor Solomon expressed that he feels that this is being rushed and there are a lot of open questions and items that need to be put in place that has yet to be addressed regarding insurance, setting precedents and crime.

Trustee Rue also stated that she feels that we will be allowing something in the Village that has never been done before and it could be to our hurt. This is a family event and we as a municipality should not promote alcohol use on Broadway, especially when we have a local law prohibiting it. They have to have a 1 million dollar insurance certificate, has that been provided, who is going to cover the additional police presence needed? These are all issues that need to be looked at.

Chief Mir stated that he doesn't feel comfortable with this permission being given. He stated that it is going to make it hard to tell someone that they cannot go to a liquor store or to another retail that sells alcohol and drink it on Broadway, which is definitely going to compromise the Village. Who is going to be responsible for these people and controlling their consumption, it all sounds good, but we have to be realistic.

Trustee Nikolados stated that the person responsible would be the bartender, just as it is at any bar you go to, the bartender monitors and tracks and amount of alcohol they are serving the individuals and uses their discretion. Both companies would bring their own person who is responsible for that and they would be in charge of that. He stated that he is sure that the Bagel Fest has the insurance, it's just a matter of getting it to the Village and he sees no reason

why this permission can't be given other than the fact of it being rushed, which is not necessarily a reason to deny it.

Mayor Solomon reinforced his statement and stated that he advises the Board to not move in this direction right now, because as it's already been discussed, there are too many loose ends that need to be tied and the event is next week. Maybe with proper planning and advance notification, it's something that can be done for next year, but not right now.
