Mr. Davidoff stated that he has to look into it because he knew nothing about this resolution or where this property is even located in the Village.

The Village Clerk stated that this is not a new property, it's only establishing a new owner, and the property is located right behind Beer World, the first big white house right after the Beer store. We have recently passed resolutions doing the same thing last year and that owner did not annex into the Village.

Trustee Weyer commented that she's aware of that law, but thought that it only pertained to commercial properties, not residential homes.

Mr. Sager stated that this is not a new property. The water has already been at the premise for years, it's only a new owner whose name is going on the contract and that's been done before.

Trustee Rue stated that she understands that it's a residential property, but the law was for all properties, both residential and commercial, like it was just done for the jail.

Trustee Lymon asked if this can be tabled until we can get clarity on the law that Trustee Rue is talking about and Michael can give us the Board the correct information.
