Shawn McMichael, the Highway Superintendent, responded that yes this is the money from last year and it has not been lost. We have to use this money before the current years money can be issued. These are the same streets from last year that was approved by the Board. Once we

utilize last year's money, we will then be issued the monies allotted for this year.

Trustee Rue commented that she feels that this is a waste of time because the Village does not have the money to do this and there was never a resolution passed holding the Village to the \$30,000.00. The Village does not have the money for this and we should not even entertain this at all. We tried this before with another company and it did not work.

Mr. Davidoff explained that this resolution does not bind the Village to anything, again it's a resolution allowing the Village more time to talk with ESG only and that's it. If the Board does not want to at least do that, there's nothing more I can say.
