Manager's Report

Mayor Sommer's read a letter he received from the County in regards to the Broadway Historic District and he also announced that there will be an informational meeting hosted by the Sullivan County Planning Board for the Broadway Historic District on Monday, November 12th, 2019 from 6-8pm here at Village Hall.

He also made the Board aware that the Village followed the NYS State Election Law and closed at 1:30pm on November 15th to allow time for the Village employees to vote.

Resolution authorizing Budget transfers for fiscal year ending July 31st, 2020

A motion was made by Trustee Nikolados with a second by Trustee Massey. Upon the call of the roll, all present were in favor.

Resolution authorizing payment to Lexipol, LLC in the amount of \$9,126.00 from app#A.3120.445-Police Training for the annual subscription and support to online law enforcement policy and procedure manual, training bulletins and testing database. Account balance after budget transfer is \$9,126.00

A motion was made by Trustee Rue with a second by Trustee Nikolados.

Trustee Massey asked if this was a sole source provider because according to the auditor's there is no such thing a sole source. There are other service providers out there, the Village just has to take the time and look for them.

Chief Mir stated that he is aware that there are others out there that provide these services, but this resolution is only to pay for the PD's annual subscription, we already have their service and to bid this out to start over, we will be looking at over \$30,000.00 due to the volume of information that is stored and what the system entails. Lexipol is a team of lawyers that work directly with the State and they do all of the legal updates and make sure that when we go into the system, we have the most current information at all times. Without them, we will be in trouble and with the service they provide, we have to be current at all times. This is paid once a year only.

Michael interjected and stated that the Chief is correct, there are only certain companies that do this and it is a very intricate part of the Police Department and must be accurate and current as soon as there are any changes, as the Chief said, this is just an annual subscription payment. To bid this out each year will be a huge detriment to the services provided by the Police Department.

Trustee Massey asked where the quotes are. Procurement is not being followed and we as the Board is allowing these purchases to be made without adequate information and the Board is going to be the one's written up by the auditor's.

Mayor Sommers stated that he agrees and Trustee Massey is correct. We need to really start being more conscious of this because procurement is being violated and I'm going to request that the Clerk write a memo to all of the Department Heads and attach a copy of the current Procurement Policy that was passed in April. As of right now, I think that we need to table this resolution.

A motion was made by Trustee Rue with a second by Trustee Sabatino to Table this resolution. Upon the call of the roll, all present were in favor.

Resolution authorizing the Adult Men's Basketball League & Agreement

Michael Davidoff read the resolution and agreement to the Board.

A motion was made by Trustee Massey with a second by Trustee Rue. Upon the call of the roll, all present were in favor.

Resolution adding a \$50.00 fee per quarter to all Village property owners who do not have the new water meters installed and authorizing the Clerk to add this fee to Chapter A-290 of the Village Code entitled, "Fee Schedule"

A motion was made by Trustee Rue with a second by Trustee Massey.

Trustee Rue asked who came up with this fee and what is it for. She stated that she was under the impression that everyone had the new meters installed and those that didn't, is it the fault of the homeowner or the company, because I know that there was a lot of times that people were not home or away and couldn't get in touch with the company or vice versa.

Mayor Sommers stated that everyone has had ample time to be in compliance with this and it is time for the Village to take action. This was the whole point of the getting the new meters and

we are still having issues with certain meters and it's all of these manual read one's.

Gary Lasher stated that he spoke with the Water Department Superintendent, Chuck Brodowsky and the Meter Reader, Chad, and they are all for it and said they have been wanting this and just waiting for the Board to take action. They said that it is currently a hassle and this will eliminate the issue of meters being incorrectly read. They are all for it.

Trustee Rue stated that this doesn't make any sense to me and I think that we need to find out all of the details of why they don't have the new meter before we start charging them.

Resolution authorizing the Correction of Errors by the Village Clerk regarding the Sewer Rate for the following Tax Parcels owned by the Sullivan County Land Bank as attached in "Schedule A"

Mr. Davidoff stated that he spoke with Mr. Hominick at the County and they are correct, there is a provision under the Law that any property owned by the Land Bank is exempt from any and all taxes including sewer taxes unless the property is being rented. As per Mr. Hominick, this is currently not the case and none of the properties are being utilized as rental units.
