#### **Mayors Report**

Mayor Nikolados stated that the Bagel & Muriel Festival will combined and both events will be held on the 2<sup>nd</sup> weekend of August, 2023. He also introduced Mrs. Vanecia Hill and her husband, who spoke to the Board in regards to setting up recreational facilities and activities in the Village. Mrs. Hill also stated that she would like to do a Caribbean Festival in June of this year if the Board would allow it.

Trustee Banks made the Board aware that the Rental Law needs to be strengthened because we have a lot of residents living in unsuitable housing, renting from absentee landlords, living in homes with numerous violations and/or that has been condemned.

After a very broad discussion, Mr. Sussman, the Village Special Counsel, said that he is aware of the housing crisis in the Village and he would like to review the current law on the books and see how it can be made more stringent to assist the residents and the Village.

<u>Discussion- Jay Zeiger-Mountaintop Villas LLC-SBL#128.-1-1, 128.-1-6.2, 128.-1-6.3 & 18.-1-4.1</u> Joel Kohn, Tom Shepstone & Ivan Kalter was present and presented a PUD (Planned Unit Development) Community to the Board for a 70 acre site off Shaker Heights Road. They stated that this is something very popular in municipalities and they wanted to introduce a preliminary plan to the Village Board to get their input.

Mr. Sussman stated that the Board can either set up zones and regulations guide-lining this or they can send it to the Planning Board of the Village and allow them to move on this proposal as they see fit, but either way, it will definitely end up at the Planning Board if it is something that the Board is interested in for review and other items. So, it is best that the Village Board take some time to explore their options.
