Motion to Accept the Agenda

A motion was made by Trustee Rue with a second by Trustee Bennett to accept the agenda with the following add-ons:

Water Project

Anthony Eagan from Barton & Loguidice started off by explaining that the Village never lost funding for the Water Project because the Village never applied for the grant. B & L wrote up all of the necessary paperwork, but the application was never submitted. In the next round of grants, the Village can move forward with the application and submission if they so desire, but as of right now, nothing has been lost.

Wastewater Project

Anthony explained that there was a bid opening the prior week for the Wastewater Treatment Plant project and the Bids came in 6.8 million dollars over the 15 million dollar budget. He explained that the Village has two options:

1. Scale down the project and rebid, which could set the project back by 4 months and all of the work must be completed and grant funds spent by September 1st, 2015 or the grant will be lost
2. Apply for a Hardship Loan from EFC, which will result in a \$4.00/month increase in fees for the taxpayers next fiscal year

According to Anthony, they have already been in contact with EFC and EFC will be presenting the issue to their loan department. They are hopeful that EFC will have a positive response.

The Board stated that they would like to talk to Treasury and speak with Council before any decisions are made.

Special Meeting

A motion was made by Trustee Rue with a second by Trustee Massey to set a Special Meeting date for Thursday, November 14th, 2013 at 2pm to follow up this meeting. Upon the call of the roll, all present were in favor.

Reschedule of Joint Meeting

A motion was made by Trustee Bennett with a second by Trustee Rue authorizing the rescheduling of the Joint Meeting with the Town of Thompson for the Broadway Fitness Center to Tuesday, December 3rd, 2013 at 6:45pm. Upon the call of the roll, all present were in favor.

Discussion-Apollo Mall

As per Trustee Rue, there is going to be a meeting in the Sullivan county Legislative Room tomorrow morning, November 7th, 2013 at 9am to discuss the sale of the Apollo Mall to the Resnick's and the Village may not be able to get the money we are owed in taxes.

Mayor Jenkins asked if all that are available on the Board to be present at the meeting, it would be appreciated. The Village is owed over \$600,000 in taxes and we cannot let that slip by us; that is money that we are in need of now.
