- Please note that the first of the 4 gateway signs purchased through last year's Sullivan Renaissance Municipal Grant Program was installed yesterday on Jefferson Street next to the UltraPower Gas Station in the newly created traffic island. I think it looks wonderful and we will be working to create a more vibrant garden area to accent it.
- Once again, this coming Saturday and Sunday is the annual Village of Monticello Spring Litter Pluck from 9:00 AM through 2:00 PM. We will be meeting at the Neighborhood Facility on both mornings where bags, gloves, "pluckers" and refreshments will be provided. I hope to see you all there.
- We recently received information from DASNY regarding the \$250,000 grant through Assemblywoman Gunther for the Jefferson Street Project. The Village Treasurer and I will be sitting down to go through the necessary paperwork so that we can receive that award from the State as quickly as possible.
- On Monday, April 24th we will be hiring a second code enforcement officer to the Building Department. The person was hired off the civil service lists following a number of interviews. He resides in the Town of Thompson and has 20 years of experience working for the City of New York in a similar capacity. It is my intent to have TJ begin to focus on strictly rental permits and inspections, while the new hire will be expected to enforce general code compliance issues throughout the village.

Village Resident Gordon Jenkins voiced his opinion about how when he was in office (Former Mayor) 3 black men, himself, T.C. Hutchins (former Trustee) and the former Code Enforcer, James Snowden all got arrested for trying to make the Village a better place for the Youth and for the residents in the Village. He went on to tell Mayor Solomon that he should do something to improve the Village.

BOND RESOLUTION OF THE VILLAGE OF MONTICELLO, NEW YORK, ADOPTED APRIL 18, 2017, AUTHORIZING CONSTRUCTION OF A NEW WATER TANK; STATING THE **ESTIMATED** MAXIMUM COST THEREOF IS \$3,850,000: APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE. INCLUDING THE EXPENDITURE OF \$3,000,000 RECEIVED OR TO BE RECEIVED **FROM** THE SULLIVAN COUNTY INFRASTRUCTURE LOCAL DEVELOPMENT CORPORATION TO PAY A PART OF SAID APPROPRIATION; AND AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF \$850,000 TO FINANCE THE BALANCE OF SAID APPROPRIATION

THE BOARD OF TRUSTEES OF THE VILLAGE OF MONTICELLO, IN THE COUNTY OF SULLIVAN, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Board of Trustees) AS FOLLOWS:

Section 1. The Village of Monticello, in the County of Sullivan, New York (herein called the "Village"), is hereby authorized to construct a new water tank. The estimated maximum cost thereof, including preliminary costs and costs incidental thereto and the financing thereof, is \$3,850,000 and said amount is hereby appropriated for such purpose. The plan of financing includes the expenditure of \$3,000,000 received or to be received from the Sullivan County Infrastructure Local Development Corporation ("LDC"), pursuant to the Water Storage Improvements Agreement dated November 11, 2016 between the Village and the LDC to pay a part of said appropriation, the issuance of bonds of the Village in the principal amount of

\$850,000 to finance the balance of said appropriation, and the collection of water rates to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the Village in the principal amount of \$850,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called the "Law"), to finance a part of said appropriation.

Section 3. The following additional matters are hereby determined and declared:

- (a) The period of probable usefulness of the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 4 of the Law, is forty (40) years.
- (b) The proceeds of the bonds herein authorized, and any bond anticipation notes issued in anticipation of said bonds, may be applied to reimburse the Village for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.
- (c) The proposed maturity of the bonds authorized by this resolution will exceed five (5) years.

Section 4. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the Village, payable as to both principal and interest by general tax upon all the taxable real property within the Village. The

faith and credit of the Village are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the Village by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 5. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes and Section 50.00 and Sections 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the Board of Trustees relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, and as to the execution of agreements for credit enhancements, are hereby delegated to the Village Treasurer, the chief fiscal officer of the Village.

Section 6. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the Village is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or (c) such obligations are authorized in violation of the provisions of the constitution.

Section 7. This bond resolution is subject to a permissive referendum and the Village Clerk is hereby authorized and directed, within ten (10) days after the adoption hereof, to cause to be published, in full, in the "Sullivan County Democrat," a newspaper having a general circulation within said Village and hereby designated the official newspaper of the Village for such publication, and posted in at least six (6) public places and in each polling place in the Village, a Notice in substantially the following form:

The Village Clerk is hereby authorized and directed to cause a summary of this Bond Resolution to be published after this Bond Resolution shall take effect, in the newspaper referred to in Section 7 hereof, and hereby designated the official newspaper for said publication, together with a Notice in substantially the form as provided by Section 81.00 of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York.

FIRST: AUTHORIZING the Village of Monticello to construct a new water tank; STATING the estimated maximum cost thereof, including preliminary costs and costs incidental thereto and the financing thereof, is \$3,850,000; APPROPRIATING said amount for such purpose; and STATING the plan of financing includes; the expenditure of \$3,000,000 received or to be received from the Sullivan County Infrastructure Local Development Corporation ("LDC"), pursuant to the Water Storage Improvements Agreement dated November 11, 2016 between the Village and the LDC to pay a part of said appropriation, the issuance of bonds of the Village in the principal amount of \$850,000 to finance the balance of said appropriation, and the collection of water rates to pay the principal of said bonds and the interest thereon as the same shall become due and payable

SECOND: AUTHORIZING the issuance of \$850,000 bonds of the Village pursuant to the Local Finance Law of the State of New York (the "Law") to finance a part of said appropriation;

THIRD: DETERMINING and STATING that (a) the period of probable usefulness of the object or purpose for which the bonds are authorized is forty (40) years; (b) the proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the Village for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized; and (c) the proposed maturity of said bonds will exceed five (5) years;

FOURTH: DETERMINING that said bonds and any bond anticipation notes issued in anticipation of said bonds and the renewals of said bond anticipation notes shall be general obligations of the Village payable by general tax upon all the taxable real property within the Village; and PLEDGING to their payment the faith and credit of the Village;

FIFTH: DELEGATING to the Village Treasurer the powers and duties as to the issuance of said bonds and any bond anticipation notes issued in anticipation of said bonds, or the renewals thereof and other powers; and

SIXTH: DETERMINING that the bond resolution is subject to a permissive referendum.
