Mayor/Manager Report

The County has received a possible grant to develop and Industrial Park at the old Apollo Mall sight. It will be a shovel ready industrial park, which I think will be good for the Village along with a grant for Daycare, which I feel that both work hand in hand. If we can get people out to work and provide a safe place for their children, it's a win-win. I would also like to take a moment and thank the County for now providing transportation for residents throughout the County. This is also a great thing because not only will our residents have a place to work at or at least be able to get to training facilities, they will have proper daycare and transportation to get there, so if all goes forward, we are definitely headed in the right direction.

<u>Presentation-Stephanie Brown Deputy Assistant County Manager-Painting of Sidewalks</u> <u>Surrounding the Government Center</u>

The Village received a Complete Streets grant a while back and was working with Wanda Cruz from Cornell Cooperative Extension, this is part of that initiative and one of my jobs at the County as the Wellness Coordinator. We would like to make a walking path of footsteps around the Government Center for its employees and visitors. We have been working to get walking paths cleared and reconstructed throughout different places around the County and at our facilities. We are also looking to do this at our Liberty Complex and have already had trails and paths re-established up there to encourage health and wellness. We are working diligently to make the employees and visitors of these facilities aware that being active throughout the work day and day period is important, getting that heart rate up is important to keep the body healthy. We will be using street paint that is reflective and non-slip to ensure the safety and wellness of those utilizing the path.

Trustee Rue asked why is this resolution is back before the Board if the NYS Comptroller's Office is here? I read the paperwork that was submitted and it says that cities are eligible, not municipalities, we are a municipality, not a city. So, I don't know why this is here before us again.

Mayor Sommers responded that is not correct, municipalities are also eligible, we spoke with the Comptroller's Office and they made us aware that we are certainly eligible to receive funds.

Gary Lasher, the Village Treasurer also responded that the Mayor is correct, we are certainly eligible and according to the Comptroller's Office, we are the poster child for something like this. Plus there is no expenses involved.

Michael Davidoff, the Village Attorney stated that we will not lose anything, if we meet the criteria and are eligible, they can help us, even if it's just in strategies or avenues to get us in a better position, but they certainly assist with municipalities. We will lose absolutely nothing by doing this either way.
