### **DIICUSSION-NEIL LARSON-HISTORICAL DISTRICT NOMINATION & 485 A TAX EXEMPTION**

Neil Larson talked about a Resolution that was passed to apply for a Grant in March 2017, he said the application was done by Helen Budrock. Mr. Larson said that he has a letter of agreement to do the work for the project and he has a draft of completion which has been submitted to the State. Mr. Larson said the State Review Board will review the application. Mr. Larson stated that he just wanted to go over the boundaries of the district, he present an Exhibit to the Board to view. Mr. Larson said that the project would extend West pass the Post Office to both sides of Broadway up Liberty Street, Landfield Avenue to the Churches and the Synagogues to St. John Street and the School. Mr. Larson said that he would apply for Tax Credits to get State Rehab Credits but the State wants to review the process this year and the property owners will be notified and they will have a Public meeting at the Village before it gets

the answer(s) from the Village Board. A young Lady from the County stated that the 485 a Tax Exemption is to create new incentives to allow for partial exemptions for non-residential buildings. The concern is to help Commercial Buildings for mixed use to make them freeze the Tax increases from 8 years to 12 years, she present a flyer to the Board on how it should work out all in an effort to help bring back downtown on Broadway (see attachment). Village Attorney Michael Davidoff questioned the fact that the Village needs to set up a meeting with the Town, the School and the County because he did not feel that the Village should say yes to a proposal that we would be the only one Adopting and no one else adopts it, she said no problem.

She said that we have a lot of qualified people in Sullivan County to do the job and they have a list at Civil Service. Mayor Sommers said that we can always consider others in the future.

### § 485-a. Residential-commercial urban exemption program

### What is the 485-a exemption program?

Section 485-a of New York State's Real Property Tax Law authorizes municipalities to enact a local law that would provide a tax incentive for the redevelopment of non-residential properties into mixed-use residential and commercial. The allowable incentive would exempt taxes on the increase in assessed value attributable to the conversion for eight years, and phase in the increase in years nine through twelve. The exemption applies *only* to the tax increases that result from the improvements and the subsequent increase in assessed property value.

### Why is the 485-a exemption beneficial?

- It can incentivize critical redevelopment of vacant and underutilized buildings in the Village's core downtown area.
- It makes conversion projects more economically viable by lessening the initial tax burden.
- It can stimulate an increase in the Village's tax base.
- Tax revenue on eligible projects is stable for the first eight years, then increases.

#### How does the 485-a exemption work?

- Adoption requires the passage of a local law.
- Exemption applies to eligible construction beginning after the municipality's local law has taken effect.
- Conversion costs must be greater than \$10,000, although municipalities may raise the threshold.
- The amount of the exemption is the current assessed value subtracted from the assessed value after the conversion.
- After a municipality adopts the exemption, the county and school district may also adopt it.
- No exemptions are allowed for special assessments.
- The exemption is applied over a 12-year period as follows:

Year of Exemption	Percentage of Exemption
1 through 8	100% of Exemption Base
9	80% of Exemption Base
10	60% of Exemption Base
11	40% of Exemption Base
12	20% of Exemption Base

### Mayor/Manager Report
