Mayor/Manager Report

Mayor Sommers submitted a report from the Building Inspector on how much fee's he collected since the \$50.00 fee was added since the last meeting, he said so far \$1,500 has been collected. Mayor Sommer's said that Monday, May 20th 2019 at the Village of Monticello Firehouse at 12:30 pm is the Training Session on Vacant, Abandoned and Deteriorated Properties and he would like for everyone to try to attend, also Sunday May 18th 2019 at 8:30 a.m. is our Annual Litter Pluck which starts at the Ted Stroebele Building. Mayor Sommers went on to say that the bags, gloves and the picker-upper stick will be available for the event.

Mayor Sommers talked about how disappointed he is about things being said on Facebook and it scares him not in the since that he is afraid to go home at night but that the people are using religion, nationality, sexual orientation, health problems, Blue Collar vs White Collar workers as issues that they having. The Mayor stated that he has a problem with this and it has been going on for way too long, he is very disappointed, very up-set and he is scared to know that people are out there with this mind set, he hopes somewhere along it gets back to them. The Mayor went on to say just calling the Village the Village De Monti Ghetto is hard and to see that there are people alive that talk like this (he stated he will stand by that statement), he went on to say that there is something wrong with people who make statements like that and if someone has a valid complaint there are valid avenues to come and make the complaints but they will not do that.

Discussion-Alex & Alla Sientsky- Forestburgh Rd Sewer Hook-Up

The Mayor and the Village Attorney Michael both agreed that the property is not adjacent to the Village and that it is located outside of the Village and there are no other properties outside of the Village that just get only sewer hook-up. Michael continued to say that he suggest that this request not be done because if you start this issue with one property then other's will want the same procedure and we should not be giving away our sewer as a Village, he went on to say that we as a Village have Police protection, Fire protection, we have water and we have Sewer, we want to encourage people to come and live in the Village to get these benefits.

Discussion-Police Department Communication Tower Quotes/Bids

Chief Mir explained to the Board how he felt about having the work done in house to save money on this Tower because there is not enough money in the budget to pay the asking price from 3 estimates, he went on to say that his budget for this is only \$25,119 and the lowest estimate starts at \$49,562. Mayor Sommers said that he highly recommend to go to bid with this but it is up to the Board to decide if working on this project in house is okay or to go out to bid. Trustees asked if people got hurt would they be covered and Michael Davidoff stated that volunteers are covered under the insurance.
